Considering : a. that based on Governor Decision Number 641/KPTS/DISPORA/2020 has been formed Support and Appointment of Prizes Governor of Sumatera Selatan Super Series Badminton 2020/2021 in the Province of Sumatera Selatan;

g. Tim Medis/Protokol Kesehatan : Rp. 2.000.000,- (dua juta rupiah) per orang per kegiatan

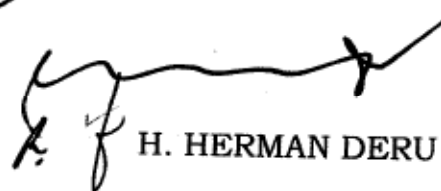
Menjadi :
